## PROCEEDINGS: IDA COUNTY BOS • DEC. 13 MINUTES & CLAIMS

## IDA GROVE, IOWA DEC. 13, 2022

The Board of Supervisors convened in adjourned session, members present Chair Raymond Drey, Creston Schubert and Rhett Leonard.

Minutes of the meeting held Dec. 6, 2022 were read and approved.

Compensation Board members Dan Remer, Sheriff's Representative; Rita Frahm, Auditor's Representative and LuAnn Bennett, Supervisor's Representative were present to advocate for their salary recommendations to align with the state ranking of the County's population ranking. Also present were Sheriff Wade Harriman, Treasurer Traci Riessen and Recorder Julie Phillips and Devlun Whiteing.

Riley Gibson, TurnKey Logistics representing Summmit Carbon Solutions was present to update the Board on the progress of the project. He also presented some permits for the County Engineer's consideration.

County Engineer Jeff Williams reported that both pickup dealerships would not guarantee that they can obtain the previously approved bid.

Ida County Fair Board members Keri Weber and Peggy Gebers were present to review their annual report and updated the Board on various improvements at the fair grounds. They also requested a possible increase in their FY-24 allocation.

Dale Ullrich, Veteran's Affairs Director was present to update the Board on various activities of the Veteran's Affairs Commission. Discussion was also held on the relocation of his office after the renovation.

Schubert moved to approve the resignation of Nathaniel Tarr, Jailer, effective Dec. 21, 2022. Drey seconded the motion and it carried, all voting Ave.

Leonard moved to approve Pat Wellendorf as Grant Township Clerk and Roger Bumann as Grant Township Trustee for a 4 year term ending Dec. 31, 2026.

A motion by Schubert and seconded from Leonard to close the Courthouse Jan. 19 and 20 and the morning of Jan. 23, 2023 to move the annex offices to various parts of the courthouse. Motion carried, all voting Aye.

Schubert moved to approve a 4% increase in the medical/self funding premium for FY-24 budget. Leonard seconded the motion and it carried, all voting Aye.

Leonard moved to approve a security system quote in the amount of \$33,852.13 from Alpha Wireless for the courthouse renovation

project. Schubert seconded the motion and it carried, all voting Aye.

A motion to approve and authorize the Chair to sign the 2022 Homestead, Military and Family Farm Credit applications for taxes payable 2023/2024 was made by Schubert and seconded by Leonard. Motion carried, all voting Ave.

The Board acknowledged receipt of manure management plans from GN2#64435/Gary Nachazel and Steve Struck.
