Brian Friedrichsen has submitted a Nutrient Management Plan (NMP) to the Iowa Department of Natural Resources (DNR) on behalf of operation with a capacity of 2300 animal units. This operation is located in Griggs Township, Ida County, and plans to apply manure in Battle, Griggs, Galva, Douglas, Logan & Silver Townships, Ida & Cherokee Counties. The NMP is on file at the DNR Field Office #3 1900 N Grand Ave., Ste E17, Spencer, IA 51301 and is available for public inspection, Monday - Friday, from 8 a.m. - 4 p.m.
In determining whether to approve the NMP, the DNR will consider written comments regarding whether the NMP complies with Iowa law. The DNR will conduct a public hearing regarding this NMP if a request for hearing is received within 10 days of the publication date of this notice. Persons requesting a public hearing will be notified of the time and place for the hearing at the address, telephone number or e-mail address provided in the request for a hearing.
